# Zimbabwean FCV Market Report as at 9<sup>th</sup> June 2017

### Crop Review:

Total crop production for the 2015/16 season was 201,953,546 Kilograms. The estimated crop size for 2017 season remains at 190 Million Kilograms. Total crop sold to date is 153,000,000 Kilograms.

#### **Commercial Growers:**

As anticipated the commercial contract deliveries have increased during the past forthnight and we expect this pace of deliveries to maintain until the end of the month and into early July.

#### **Small Scale Growers:**

Since the start of the season this sector has sold a considerable amount of volume across all sales floors; in a relativey short period. Therefore, as we near the end of these volumes these deliveries will slow down significantly during the course of this month.

# **Contract Buying Floor Quality Styles and Offerings:**



1. During this period Small Scale offerings leaned towards medium / good quality upper stalk ripe light orange / orange tobaccos.

2. Generally the Commercial tobaccos seen to date are a cleaner more standard style. The upper stalk styles predominately range between orange / orange mahogany leaf.

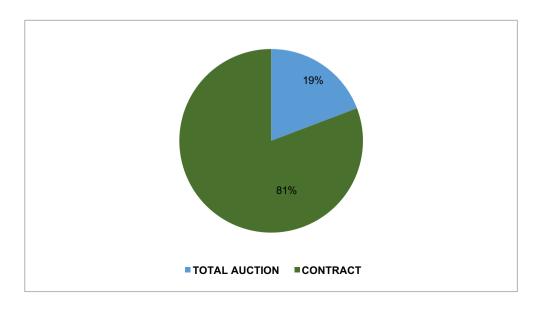
# Auction Floors:

1. Total mass sold on the Auction Floors is  $\frac{1}{2}$  3 million kilograms higher compared to the same period in 2016. This illustrates a 12.26% increase in volumes purchased for the 2017 crop.

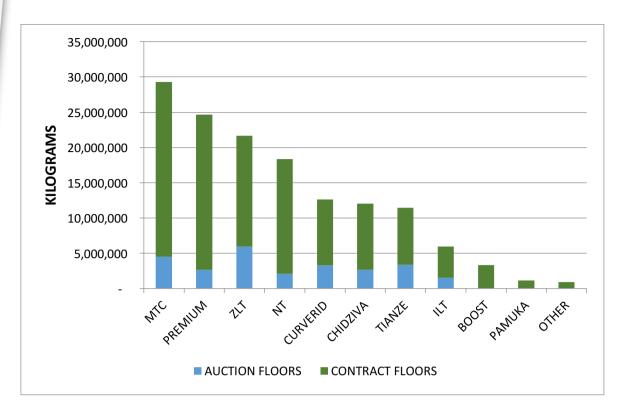
2. The overall average price on the Auction Floors remains higher than that of last year; At US\$2.88 per/kilogram compared to US\$2.55 per/kilogram. This represents a 12.92% increase.

3. Similiar offerings remain in terms of plant position auction vs. contract.

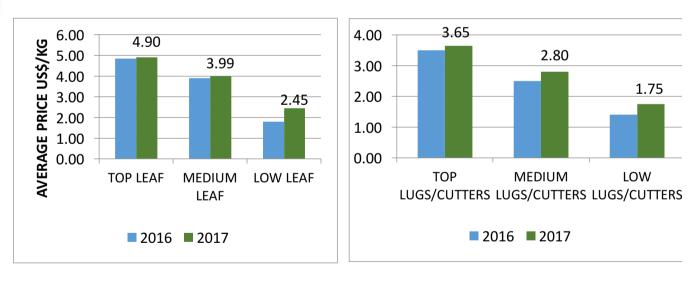
# Pie Chart Representing the Difference between Contract and Auction

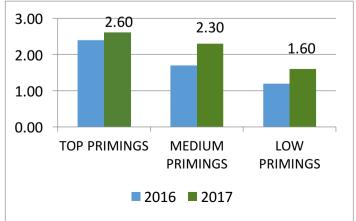






# Difference in Average Price per Plant Position for 2016 – 2017
