
Auction Floors:

- Offerings on the auction floors during this stage of the marketing season are now naturally dominated by leaf and cutters, with a few occasional deliveries of lugs.
- We have seen a -26.22% decrease in mass sold across the auction floors compared to the 2015 season.
- The average price continues to remain higher than last year with a 0.85% increase. Lower to middle lugs are fetching +/-35c more than in 2015. The top end of leaf and cutters remain of exceptional quality and are still firm in terms of prices, fetching between US/KG\$4.00 and US/KG\$4.99.


Contract Buying Floor Quality Styles and Offerings:

- The mass sold continues to rise as the season progresses, with a 23.82% increase compared to the same period in 2015. The Trade has received +/-21,900,000kg more tobacco compared to last year at this point in time.
- The average price on the contract floors is slightly higher than that of the auction floors; this is directly due to the quality of tobacco grown by the Contract growers. The seasonal statistics show that the average price is -3.98% lower and sitting at US/KG \$3.00 compared to US/KG\$3.13 in 2015.
- A total volume of 140.738.395 Kg's has been purchased by merchants up to the 20/6/2016. Large volumes are still being purchased on the contract floors with the auction floor volumes starting to decline. With the current volumes still coming in we believe it is fair to say the crop size will be over 160 million Kg's and between the original estimate of 160-185 million Kg's.
